CONDITIONS OF CONTRACT

- 1. In tendering the shipment for carriage, the shipper agrees to these terms and conditions of contract which no agent or employee of the parties may alter...
2. The shipper agrees that carriage is subject to terms and conditions of the most recent Shaker Group, Inc. Service Guide...
3. In tendering the shipment for carriage, the shipper warrants that the shipment is packaged adequately to protect the enclosed goods...
4. When the destination of the shipment is not within the Shaker Group, Inc. terminal delivery area...
5. Declared value and limitation of liability: The liability of Shaker Group, Inc. is limited to the sum of \$50.00 unless a higher value is declared...
6. Claims, written notice or loss due to damage, shortage or delay must be reported by the shipper within 12 days after the delivery of the shipment...
7. All shipments are subject to inspection by Shaker Group, Inc., including but not limited to, opening the shipment...
8. Notwithstanding the shipper's instructions to the contrary, the shipper shall be primarily liable for all costs and expenses related to the shipment...
9. The shipper is required to indicate the type of service requested. In the absence of any instructions, overnight rates and services will apply...
10. Shaker Group, Inc. shall have the right to retain in its possession this shipment, or any subsequent shipment by the shipper as security for the payment of outstanding shipping charges...
11. By depositing the shipment for carriage or accepting the shipment, the shipper, consignor, and the consignee respectively acknowledge that they are jointly and severally liable for the freight charges...
